Club History

Buffalo Field Archery Club (BFAC) was founded in 1948. Since inception BFAC has carried on a mission of promoting the enjoyment of archery and a tradition of outdoor sportsmanship. Club membership includes families and individuals of all ages, shooting styles and skill levels. BFAC is a non-profit volunteer community service organization. Operating expenses are funded by membership fees and proceeds from BFAC sponsored shoots.

Membership Benefits

Outdoor Range: For just a few dollars per month members enjoy unlimited, year round to one of the nicest outdoor archery ranges in Texas. Facilities include:

- **Practice Range:** 21 high density foam backstops set at 10 yard increments. Half of the range is set with targets from 10 yards to 80 yards, half of the range is set with targets from 15 yards to 65 yards and one target set at 90 meters.
- **Field Range:** Walk through field range course in a wooded/shaded setting, with high density foam backstops
- **3D Range:** The club has 50 available 3D targets and hosts 3D shoots). The course consists of at least 20 3D animal targets set in a wooded/hunting type setting.

Annual Membership Fees

Membership fees are \$130.00 for both individual and family Memberships. **Membership expires December 31, 2012.**

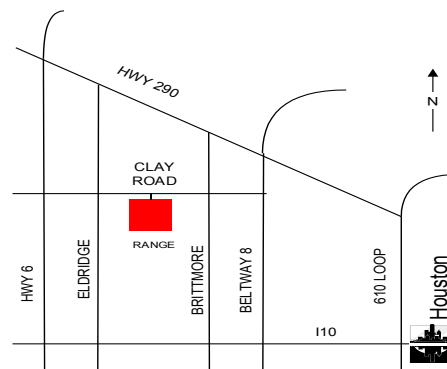

Buffalo Field Archery Club, Inc. and Cullen Park Range Rules and Regulations

1. **Crossbows, broadheads, guns, firearms, pets and alcoholic beverages are not allowed at the range.**
2. Any device that locks a bow at full or partial draw is not allowed at the range.
3. Children under the age of twelve require adult supervision.
4. A bow placed in front of a target means the target is unsafe to shoot (i.e. someone is behind the target).
5. No sky pulling.
6. **Hunting is NOT allowed at the range.**
7. Members and guests must sign a release, waiver and indemnity agreement.
8. Members are not to hand out gate codes. Doing so can lead to expulsion without refund.
9. No backtracking on ranges.
10. Members are to wait for all shooters before advancing from the firing line.
11. If searching for a lost arrow, place your bow in front of the target. Do not commence firing if you observe a bow in front of the target.

I do hereby for and on behalf of myself, my heirs and legal representatives RELEASE AND FOREVER DISCHARGE the City of Houston, Texas and Buffalo Field Archery Club, Inc. (hereinafter referred to as "BFAC"), its officers, directors, members, representatives, and volunteers, from any and all claims, demands and injuries, howsoever arising, whether caused by the negligent or intentional acts of BFAC or any of its officers, directors, members, representatives, and volunteers, or by third parties, which injuries may be in any way related to my activities as a member of BFAC and/or while on the premises of BFAC, and all such claims are hereby WAIVED AND RELEASED, and I agree not to sue therefore.
